

**Black Friday Sweepstakes
Official Rules**

- **VOID WHERE PROHIBITED BY LAW.**
- **ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

1. **ELIGIBILITY:** The Black Friday Sweepstakes ("Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia, who are eighteen (18) years of age or older as of date of entry, and, for Game Pieces, who are among the first two hundred (200)* customers to be shopping at a participating Kohl's location during the Sweepstakes Period. Employees, officers and directors of Kohl's, Inc. ("Sponsor"), Realtime Media LLC ("Administrator") and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies (collectively, the "Sweepstakes Parties"), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. In the event that a household, based on address, enters the Sweepstakes using more than five (5) unique email addresses, all of the Sweepstakes entries associated with that household (determined by Sponsor or Administrator at their sole discretion) will be disqualified. Void where prohibited by law. All federal, state and local laws and regulations apply. 2. **TIMING:** The Sweepstakes Game Piece Distribution Period begins at or about 5:00 a.m. local time (actual time depends on when Kohl's store location opens for business on 11/29/24) on November 29, 2024 and ends at 8:00 a.m. local time the same day, November 29, 2024, or when all two hundred (200)* game pieces (each a "Game Piece") allocated to the applicable Kohl's store have been distributed, whichever is earlier (the "Sweepstakes Period" or "Game Piece Distribution Period"). If you receive a Game Piece during the Sweepstakes Period and you are the winner of a Kohl's Cash® prize, you must redeem it in store or online the same day, before 11:59 p.m. local time on November 29, 2024, or before the store closes, whichever is earlier, or your prize will expire and remain un-awarded. If you are the winner of any other prize, you must redeem it online according to the instructions on the winning Game Piece at any time after 5:00 a.m. Eastern Time ("ET") on November 29, 2024 and before December 13, 2024, at 11:59 p.m. ET (the "Online Prize Redemption Period" or "Redemption Period") or you will forfeit the prize. The designated computer clock of the Sponsor is the official time-keeping device for the Game Piece Distribution Period in the Sweepstakes. The designated computer clock of the

Administrator is the official time-keeping device for the Online Prize Redemption Period for non-Kohl's Cash® prizes in the Sweepstakes.

3. **HOW TO PARTICIPATE:** During the Sweepstakes Period, if you are eligible, visit a participating Kohl's store and if you are determined to be one of the first 200* people to enter the store, as determined by Sponsor's agent, in their sole discretion, you will receive a Game Piece, while supplies last. Limit: one (1) Game Piece per person. You must have access to the Internet, a valid email address, and a valid physical mailing address (no P.O. Boxes) to claim a non-Kohl's Cash® prize.

The sole responsibility for any irregular game piece is replacement with another randomly selected Game Piece or code, provided supplies last at a given Kohl's store location; and, if supplies of Game Pieces are depleted at such affected Kohl's store location, Sponsor and Administrator shall not have any liability whatsoever relative to such irregular Game Piece. Each Game Piece/code may only be submitted once. Codes submitted (and Game Pieces redeemed, as applicable) in any manner other than as stated in these Official Rules are void and will not be honored or returned. If a Second Chance Drawing is needed, the potential winner(s) will be notified via email (or other contact information) using the information provided on the Second Chance Drawing entry form in a commercially reasonable time after the drawing, if any. The Sweepstakes Parties are not responsible for and shall not be liable for incorrect, changed, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering, or insufficient space in entrant's email or other account to receive messages.
