

### STEP 1

A. PLACE RIGHT ARM (C) ON A FLAT, PROTECTED SURFACE.

B. ATTACH SEAT (A) TO RIGHT ARM (C) USING LARGE BOLT (E) AND LARGE WASHER (F)
USING ALLEN WRENCH (H)
DO NOT TIGHTEN COMPLETELY.




### STEP 2

A. ATTACH BACK (B) BY ALIGNING 2 BACK PINS WITH THE HOLES ON RIGHT ARM (C) AND INSERTING 2 SEAT PINS INTO HOLES ON BACK (B).

B. INSERT SMALL BOLT (I) WITH SMALL WASHER (J) THROUGH BACK (B) INTO SEAT (A). USING SMALL ALLEN WRENCH (L). DO NOT TIGHTEN COMPLETELY.

C. INSERT SMALL BOLT (I) WITH SMALL WASHER (J) THROUGH RIGHT ARM (C) INTO BACK (B) USING ALLEN WRENCH (L). DO NOT TIGHTEN COMPLETELY.





A. ATTACH LEFT ARM (D) BY INSERTING 2 BACK PINS INTO HOLES IN LEFT ARM (D).


B. INSERT LARGE BOLT (E) WITH LARGE

LEFT ARM (D) USING LARGE ALLEN WRENCH (H).
DO NOT TIGHTEN COMPLETELY.

C. INSERT SMALL BOLT (I) WITH SMALL
WASHER (J) THROUGH LEFT ARM (D)
INTO BACK (B) USING SMALL ALLEN WRENCH (L).
DO NOT TIGHTEN COMPLETELY.






G. COVER SMALL BOLTS (I) USING SMALL BOLT CAPS (K).



### STEP 4

A. ATTACH BASE (M) TO RIGHT ARM (C) AND LEFT ARM (D) BY ALIGNING 4 BOLTS ON BASE WITH HOLES ON ARMS USING LARGE ALLEN WRENCH (H). TIGHTEN COMPLETELY.

B. COVER BOLTS USING LARGE BOLT CAPS (G).
